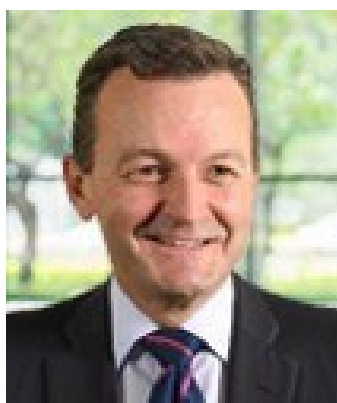
After graduation from UNSW, Bob Cameron had a successful career as an executive and entrepreneur in the resources sector while holding many roles in community, governmental and industry organisations.

Justine Jarvinen (JJ) is the Managing Principal, Sustainability and Climate Change at Aurecon, a leading engineering and design firm.

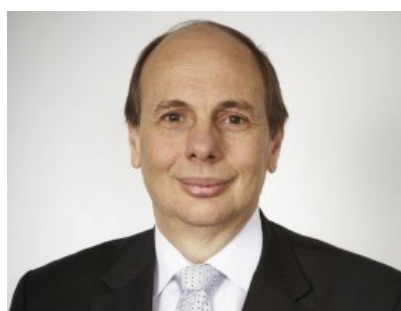

Simon represented Australia in Rugby Union from 1980 to 1992, captaining the Wallabies in 1986 and 1987, becoming the first Wallaby to play 50 test matches. In total, he played 59 test matches including 21 against the New Zealand All Blacks - a record at the time for an Australian forward. In 1991 Simon was a member of the first Wallaby team to win the Rugby World Cup. He is one of only four players in the history of Australian Rugby, along with David Campese, Nick Farr-Jones and Michael Lynagh to have won Rugby Union's Grand Slam, achieved a Bledisloe Cup series in New Zealand and won a Rugby World Cup.

Simon co-founded the establishment of the "UNSW Lexcen Sports Scholarships" in 1988 - the first sports scholarship program introduced into an Australian University. The "Lexcen Sports Scholarships" program has supported over 225 UNSW Lexcen Elite Scholars since its inception, 23 of whom have become Olympians.

Simon was inducted into the NSW Hall of Champions in 1980, the Australian Hall of Fame in 1991 and into the Australian

Rugby Hall of Fame in 2014. He was awarded the Centenary Medal in 2001 and the Australian Sports Medal in 2000.

He holds a Blue in Rugby Union from UNSW, is a member of the UNSW Sporting Hall of Fame and was awarded a prestigious Alumni Award by UNSW in 1990.

During her decade-long membership of the Australian Commonwealth Statutory Advisory Committee on Medical Devices up to 2013, she advised the Australian Therapeutic Goods Administration on safety of medical devices.
